- 10.1 provide **THREE (3)** distinct differences between social and environmental injustices **Environmental injustices** occur when: **(3 marks)** 
  - \* people with fewer choices, such as the poor and disadvantaged, suffer the most from pollution, from work that is dangerous to their health, and from not having access to resources
  - \* there is resource depletion, which is e.g. the loss and lessening of fishing stock, trees and firewood
  - \* poor people also have unequal access to basic resources such as water and electricity

## Social injustices happen when: (3 marks)

- \* people with fewer choices, such as the poor and disadvantaged, suffer the most from discrimination based on e.g. ability, age, culture, gender, race and religious beliefs
- \* people with fewer choices lack acknowledgement of their human rights and access to services such as health care, housing, and a good education
