- All churches were closed, so all services were moved to online platforms.
- Some churches used Zoom as a means to conduct services, where the preacher can be seen by the participants and the preacher can see who is connected.
- Some church leaders used Facebook live to connect with their members.
- Many churches even established WhatsApp groups where pictures of the different preachers and sermons in the form of voice notes were uploaded.
- Funerals also went virtual with the restrictions of movement between provinces and the limited numbers of people who could attend.
- Many funeral services were broadcasted live on Facebook.
- The time allocated for funerals is drastically reduced to 2 hours from house to the grave, including the service in the church.
- Attendance registers, temperature measurements and sanitising stations became the new normal.
- For most of the lockdown, marriage ceremonies were limited to 50 attendees. Zoom and Facebook became the go to apps to broadcast to those who could not attend.
